

## **EXTERNAL BARTENDER AGREEMENT**

This External Bartender Agreement (“Agreement”) is entered into between \_\_\_\_\_ (“Bartender”) and Supreme Eventz (“Venue”) for services provided at the event scheduled on \_\_\_\_\_.

By signing below, Bartender acknowledges and agrees to the following terms and conditions:

### **1. Compliance with Venue Policies**

Bartender agrees to comply with all rules, policies, procedures, and instructions established by Supreme Eventz, including any directives given by the venue owners, managers, coordinators, or authorized representatives during the event.

Supreme Eventz reserves the right to require immediate corrective action or removal of any bartender or staff member acting in violation of venue policies, behaving unprofessionally, or creating a safety concern.

### **2. Bartender Equipment and Supplies**

Bartender shall be solely responsible for providing their own professional bartending tools, bar kits, dispensers, pour spouts, mixers, garnish containers, serving accessories, and any other equipment necessary to properly perform bartending services.

Unless otherwise expressly approved by Supreme Eventz management, venue equipment and supplies shall not be assumed to be available for bartender use.

### **3. Prohibition on Alcohol Sales**

Bartender expressly acknowledges that they are not permitted to sell alcoholic beverages on the premises of Supreme Eventz under any circumstances unless expressly authorized in writing by Supreme Eventz and permitted by applicable law and licensing requirements.

This prohibition includes, but is not limited to:

- Charging guests directly for alcoholic beverages;
- Accepting cash, electronic payments, tips in exchange for drinks, or drink tickets for alcohol purchases;
- Operating cash bars;
- Selling shots or premium pours;
- Collecting money through digital payment applications for alcoholic beverages.

If Supreme Eventz determines, in its sole discretion, that unauthorized alcohol sales are occurring or have occurred, the event may be terminated immediately without refund, all alcohol service shall cease immediately, and the matter may be reported to the appropriate local or state authorities, including alcohol beverage control enforcement agencies and/or law enforcement.

Any resulting fines, penalties, legal claims, damages, or liabilities arising from unauthorized alcohol sales shall be the sole responsibility of the Bartender and/or Host.

#### **4. End of Alcohol Service**

Bartender expressly agrees that all alcohol service shall conclude immediately and precisely at the scheduled end time of the event, as determined by Supreme Eventz.

Bartender shall not serve any alcoholic beverages, including but not limited to shots, “last call” rounds, doubles, after-hours drinks, or unofficial service after the conclusion of the event. Bartender understands that continued alcohol service after the event encourages guests to linger on the premises and may increase the likelihood of intoxicated driving, disturbances, accidents, injuries, or property damage.

#### **5. Responsible Alcohol Service**

Bartender agrees to exercise reasonable care and professional judgment in the service of alcohol and agrees not to knowingly overserve any visibly intoxicated, impaired, aggressive, underage, or belligerent individual.

Bartender further agrees to:

- Refuse service when appropriate;
- Monitor guest intoxication levels responsibly;
- Avoid excessive or reckless alcohol distribution;
- Comply with all applicable federal, state, and local laws regarding alcohol service.

Bartender represents that they possess any licenses, permits, certifications, or training required by law to legally serve alcohol.

#### **6. Water Accessibility**

Bartender agrees to ensure that water provided by the host remains readily visible and accessible to guests throughout the duration of alcohol service.

#### **7. Ice Provision**

Supreme Eventz will provide six (6) twenty-pound bags of ice for the event.

Any additional ice required beyond this amount shall be the sole responsibility of the Bartender and/or Host to obtain at their own expense. Supreme Eventz is under no obligation to provide additional ice beyond the initial allotment.

### **8. Venue Property**

Bartender agrees that no property, supplies, inventory, or materials belonging to Supreme Eventz may be removed from the premises without express authorization from venue management.

This includes, but is not limited to:

- Cups;
- Napkins;
- Straws;
- Drinkware;
- Mixers;
- Ice buckets;
- Cleaning supplies;
- Disposable products;
- Bar equipment;
- Remaining or unused venue inventory.

Unauthorized removal of venue property may result in charges, deductions from the Host's security deposit, and/or immediate prohibition from future events at Supreme Eventz.

### **9. Security Deposit Liability**

Bartender acknowledges and agrees that violations of this Agreement, venue policies, alcohol service rules, unauthorized alcohol sales, overtime occupancy caused by continued alcohol service, property damage, guest misconduct resulting from overservice, or failure to comply with directions from venue management may result in deductions from the Host's security deposit.

Bartender further understands that Supreme Eventz reserves the right to hold the Host financially responsible for damages, additional staffing costs, extended venue occupancy,

excessive cleanup, security intervention, fines, violations, or other liabilities resulting from the Bartender's actions or failure to adhere to venue policies.

### **10. Indemnification and Liability**

Bartender agrees to assume full responsibility for their own conduct and the conduct of any assistants, barbacks, employees, contractors, or representatives working under their direction.

Bartender agrees to indemnify, defend, and hold harmless Supreme Eventz, its owners, employees, agents, affiliates, and representatives from and against any and all claims, liabilities, damages, losses, fines, penalties, lawsuits, costs, or expenses arising out of or related to:

- Alcohol service provided by Bartender;
- Overservice of alcohol;
- Unauthorized alcohol sales;
- Injury, death, accident, or intoxication involving guests;
- Violations of alcohol laws or regulations;
- Property damage caused by Bartender or intoxicated guests;
- Failure to comply with venue policies or applicable laws.

Supreme Eventz assumes no responsibility or liability for the acts, omissions, negligence, or alcohol-related decisions of any external bartender.

### **11. Property Damage**

Bartender agrees to use reasonable care while operating on the premises and accepts responsibility for any damage caused by Bartender, their staff, equipment, or negligence.

### **12. Acknowledgment**
